**CALL TO ORDER** – Mayor Kaminskas called the meeting to order at 6:00 p.m.

**ROLL CALL**

The mayor and city council reconvened the regular meeting at 7:02 p.m. Mayor Pro Tem Kennedy nominated Dannetta Garcia, seconded by Councilman Langford. Councilman Dunne nominated Tim Olsen, seconded by Councilman Severs. Mayor Kaminskas called for a hand vote on the first nomination. Mayor Pro Tem Kennedy, Councilman Langford, and Council Member Kurtz voted in favor. Mayor Kaminskas called for a hand vote on the second nomination. Councilmembers Dunne, Folyer, and Severs voted in favor, resulting in a 3-3 tie. Mayor Kaminskas broke the tie, choosing Dannetta Garcia to fill the vacant seat for Position 7.

The city clerk then administered oath of office for Councilmember Garcia.
