

**RESOLUTION NO. 03-57
CITY OF LIBERTY LAKE
SPOKANE COUNTY, WASHINGTON**

**A RESOLUTION OF THE CITY OF LIBERTY LAKE, WASHINGTON, RELATING TO
ADMINISTRATIVE FEES CHARGED FOR SERVICES PROVIDED BY THE CITY.**

WHEREAS, the City is authorized to establish fees and charges for services provided; and

WHEREAS, the City is desirous of recovering the cost of services through the imposition of fees and charges where appropriate.

NOW, THEREFORE, the City Council of the City of Liberty Lake, Washington, do ordain the following fees and charges shall be assessed as follows:

Section 1. Animal Licenses. In addition to the provisions set forth in Ordinance 111, adopted by the City Council on February 4, 2003, the following fees shall be assessed annually for the purposes of issuing animal licenses: Dogs Spayed \$ 10.00, Dogs Unspayed \$ 28.00; Cats Spayed \$5.00, Cats Unspayed \$18.00. A 45-day late fee of \$20.00 is authorized following notification to pet owners on the first day of the following month.

Section 2. Business Licenses. In addition to the provisions set forth in Ordinance 67, adopted by the City Council on September 18, 2001, the following fees of \$35.00 and \$20.00 for businesses with revenue less than \$10,000 shall be assessed annually. A late fee of \$17.50 and/or \$10.00 shall be imposed upon failure to obtain a business license within 45-days of notification. Notices will be sent to prospective business owner(s) on the first day of the following month.


Section 3. Copy Fees. Are hereby set at .15 cents per copy with no charge for the first (5) five pages.

Section 4. Non-Sufficient Funds Fee (NSF). In addition to the provisions set forth in the Financial Management Policy adopted by Resolution 02-048 on June 18, 2002, by the City Council, a fee of \$35.00 shall be assessed for all returned checks tendered to the City of Liberty or to Trailhead Golf Course.

Section 5. Peddler/Solicitor/Master Solicitors License Fee. In addition to the provisions set forth in Ordinance 97, adopted by the City Council on August 20, 2002, the following fees of \$150.00 for a Master Solicitor license and \$75.00 for a Peddler/Solicitor License shall be assessed annually.


Section 6. Effective Date. This Resolution shall become effective immediately upon passage by the Liberty Lake City Council.


