**A RESOLUTION OF THE CITY OF LIBERTY LAKE, WASHINGTON, REPEALING
RESOLUTION NO. 05-80 AND ESTABLISHING A NEW FEE SCHEDULE FOR
TRAILHEAD GOLF COURSE.**
