**A RESOLUTION OF THE CITY OF LIBERTY LAKE AUTHORIZING AND
APPROVING PARTICIPATION IN THE WASHINGTON PUBLIC EMPLOYEES'
RETIREMENT SYSTEM (PERS)**

WHEREAS, the City Council desires for its qualified employees to participate in the Washington Public Employees Retirement System (PERS)

NOW, THEREFORE, be it resolved by the City Council of the City of Liberty Lake, Washington as follows:

Section 1. Authorization to Participate. The City Council of the City of Liberty Lake, a political subdivision of the State of Washington, authorizes and approves its eligible employees to participate in the Washington Public Employees Retirement System (PERS) as allowed by RCW 41.40.062; and authorizes the expenditure of the necessary funds to cover its proportionate share for participation in the System.


Section 2. Effective Date. Membership shall commence as of January 1, 2010.

Section 3. Tax Status. The City of Liberty Lake will submit tax-deferred member contributions beginning January 2010.

Section 4. Purchase of Previous Service. The member pays all previous service costs (both member and employer contributions). Payment will be completed within five years from entry into PERS.

Section 5. Severability. If any section, sentence, clause or phrase of this Resolution shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause, or phrase of this Resolution.




