RESOLUTION NO. 13-167

**A RESOLUTION WAIVING THE COMPETITIVE BIDDING REQUIREMENTS  
DUE TO A SOLE SOURCE PURCHASE AND AUTHORIZING THE PURCHASE  
OF VORTAX SOFTWARE**

WHEREAS, the City Council finds that based upon findings by the City's Finance and Administration Department, the purchase of Vortax software from Spokane County, Washington is appropriate due to the exclusiveness and operational capabilities of the software; and

WHEREAS, RCW 39.04.280 provides that a local agency, by Resolution, may waive the competitive bidding requirements when the purchase is clearly and legitimately limited to a single source of supply, or when the purchase involves special facilities or market conditions; and

WHEREAS, the City Council finds that it is in the best interest of the City to purchase the Vortax software to provide comprehensive reporting and analysis of the City's sales tax data that will satisfy the City's needs; and

WHEREAS, Spokane County is the sole source of supply of the Vortax software; and

WHEREAS, is it appropriate for the City Council under RCW 39.04.280 to waive the competitive bidding requirements for the above reasons; and

NOW, THEREFORE, it is hereby resolved by the City of Liberty Lake City Council the following:

1. Pursuant to RCW 39.04.280, the competitive bidding requirements for the purchase of Vortax software from Spokane County are waived as a sole source purchase, and
2. The City is authorized to purchase the Vortax software under the terms and conditions of a Licensing Agreement with Spokane County in the amount of three thousand dollars (\$3,000).


