A RESOLUTION SUPPORTING LIBERTY LAKE FIELDS

WHEREAS, the City of Liberty Lake is a growing community with many needs, including the need for areas where citizens can enjoy recreational and outdoor activities;

WHEREAS, the City of Liberty Lake recognizes the increasing need for more recreational fields within the City boundaries; and

WHEREAS, the City Council of Liberty Lake further recognizes the role of the City to support the effort it providing more recreational fields for its citizens; and


WHEREAS, in 2012, the City of Liberty Lake and the Central Valley School District entered into an agreement for the City to purchase School District Property ("Liberty Lake Fields") within the City's boundaries with the purpose of developing Liberty Lake Fields into multiple athletic fields to assist the needs of the citizens; and

WHEREAS, in 2013, the City Council appropriated \$500,000 from Fund 311 towards the development of Liberty Lake Fields;

NOW, THEREFORE, it is hereby resolved by the City Council of the City of Liberty Lake, Washington, as follows:

1. To support the design and development of Liberty Lake Fields as identified and approved by the Liberty Lake City Council in Exhibit A; and
2. To finance Liberty Lake Fields using City funds identified and approved by the Liberty Lake City Council under Exhibit B.





