**A RESOLUTION PROVIDING FOR THE DISPOSAL OF A CERTAIN ASSET ITEM  
DEEMED TO BE SURPLUS AND NO LONGER USED BY THE CITY OF LIBERTY  
LAKE, WASHINGTON**

WHEREAS, a certain fence that belongs to the City of Liberty Lake is in poor condition and no longer needed by the City; and

WHEREAS, to remove the fence would mean extra time and expense for City Staff, including providing a place for storage;


WHEREAS, having a person or company remove and take the fence in lieu of any financial consideration is in the best interest of the City of Liberty Lake;

AND WHEREAS, the City believes that it is in the best public interest to authorize the Mayor or designee to negotiate removal of the asset without any financial payment from the City and to have the entire fence removed from the property located on 22710 E Country Vista Drive as described in Exhibit A.

NOW, THEREFORE, be it resolved by the City Council of the City of Liberty Lake, Washington, as follows:

The fence belonging to the City of Liberty Lake as shown in Exhibit A is declared to be surplus to the foreseeable needs of the City and it is deemed to be for the common benefit of the residents of the City to dispose of said asset. The Mayor is authorized to dispose of the items listed in this Resolution in a manner that will be to the best advantage of the City of Liberty Lake.


