

**ORDINANCE NO. 107-C  
CITY OF LIBERTY LAKE  
SPOKANE COUNTY, WASHINGTON**

**AN ORDINANCE AMENDING ORDINANCE NO. 107-A PASSED BY THE CITY COUNCIL ON JULY 15, 2003, AND ORDINANCE NO 107-B PASSED BY THE CITY COUNCIL ON OCTOBER 7, 2003, ENTITLED "AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON, ADOPTING A BUDGET FOR THE PERIOD JANUARY 1, 2003 THROUGH DECEMBER 2003, APPROPRIATING FUNDS AND ESTABLISHING SALARY SCHEDULES FOR ESTABLISHED POSITIONS."**

WHEREAS, subsequent to the adoption of the annual budget, it has become necessary to make changes in certain appropriations.

WHEREAS, the above changes could not reasonably have been anticipated or known at the time Ordinance No. 107 was passed by the City Council; and

WHEREAS, the City Council has determined that the best interest of the City is served by amending the adopted budget approved in Ordinance 107; and

NOW, THEREFORE, the City Council of the City of Liberty Lake, Washington, do ordain as follows:

**Section 1. Budget Amendment.** The Golf Course Acquisition Fund (325) of the annual budget is amended to provide for funds necessary to pay for additional expenses related to the remodel project. The General Fund is amended to transfer \$1,321.92 from unexpended appropriations to line item 325.000.325.594.79.62.00. Any remaining funds following payment of all invoices shall be transferred back to the General Fund and the Golf Course Acquisition Fund will be closed.

**Section 2. Budget Amendment.** The LTGO Bond Fund (211) of the annual budget is amended to provide for funds necessary to pay for the Principal and Interest on the 2002 General Obligation Bonds. The General Fund is amended to transfer \$44,398.74 from the unexpended appropriations to the LTGO Bond Fund.

**Section 3. Budget Amendment.** The Street Fund (110) is amended to appropriate available funds to purchase capital equipment in the amount of \$29,000. Funding for these expenses are derived from existing budget appropriations.


**Section 4. Budget Amendment.** The Stormwater Utility Fund (410) is hereby amended to appropriate available funds to purchase capital, utility and maintenance equipment in the amount of 36,000.00. Funding for these expenditures are derived from existing budget appropriations.

**Section 5. Budget Amendment.** The General Fund "Library" line items are hereby amended to appropriate available funds to pay for the Library Director's salary and benefits for the month of December 2003. Funding for these expenditures are derived from existing budget appropriations. Amount not to exceed \$5,000.00.

**Section 6. Effective Date.** The Liberty Lake City Council declares that the amendments are effective five days following publication of the ordinance.

**Section 7. Severability.** Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal laws or regulations, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.


