

**RESOLUTION NO. 14-184
CITY OF LIBERTY LAKE
SPOKANE COUNTY, WASHINGTON**

**A RESOLUTION WAIVING THE COMPETITIVE BID REQUIREMENTS DUE
TO A SOLE SOURCE PURCHASE AND AUTHORIZING THE PURCHASE OF
AN AUTOMATED LICENSE PLATE READER CAMERA SYSTEM**

WHEREAS, the City Council finds that based upon research by the Liberty Lake Police Department, the purchase of an automated license plate reader camera system is appropriate due to the exclusiveness and quality of the product; and

WHEREAS, RCW 39.04.280 provides that a local agency, by Resolution, may waive the competitive bidding requirements when the purchase is clearly and legitimately limited to a single source of supply, or when the purchase involves special facilities or market conditions; and

WHEREAS, the City Council finds that there is an automated license plate reader camera system supplier that will meet the specific facilities of the Liberty Lake Police Department by utilizing the current computer server and facilities located at the Spokane Police Department; and

WHEREAS, the manufacturer of the computer software is the sole source of supply, and such software creates a special market condition because of the compatibility of the sole source supplier and facilities; and

WHEREAS, it is appropriate for the City Council under RCW 39.04.280 to waive the bidding requirements for the above reasons; and

NOW, THEREFORE, it is hereby resolved by the City Liberty Lake City Council the following:


1. The competitive bidding requirements for the automated license plate reader camera system is waived as this is a sole source purchase involving special facilities and market conditions and compatibility with the certain software, and
2. The City's purchase for the automated license plate reader camera system manufactured by 3M is authorized in the amount not to exceed \$17,500, which includes taxes, installation, and training.




