RESOLUTION NO. 16-205**

**A RESOLUTION OF THE CITY OF LIBERTY LAKE, WASHINGTON NAMING
LIBERTY LAKE BALL FIELDS AS “THE DIAMONDS AT LIBERTY LAKE” AND
PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, in May, 2013, the City of Liberty Lake (“City”) purchased certain real property (“Property”) from the Central Valley School District (“CVSD”) to accommodate the City’s growth and recreational needs; and

WHEREAS, the City and CVSD executed a Purchase and Sale Agreement that provided for improvements to the Property, including the construction of baseball fields; and

WHEREAS, the City improved the Property by constructing two (2) baseball fields on a portion of the Property; and

WHEREAS, in December 2015, the City and CVSD amended the terms of the Purchase and Sale Agreement to amend CVSD’s purchase option on the Property to provide the City with sole ownership of the real property where the baseball fields were constructed; and

WHEREAS, on January 5, 2016, the City received a \$5,000 donation from the Liberty Lake Field Team, in coordination with River View Little League, to be utilized in the purchase and installation of a scoreboard at the baseball fields; and

WHEREAS, the Liberty Lake Field Team, in coordination with River View Little League, requested the City officially name the baseball fields as “The Diamonds at Liberty Lake”.

NOW, THEREFORE, it is hereby resolved by the City Council of the City of Liberty Lake, Washington as follows:

Liberty Lake Ball Fields are hereby officially named “The Diamonds at Liberty Lake”.

This Resolution shall be in full force and effective immediately upon its passage and adoption.


