

**RESOLUTION NO. 16-208
CITY OF LIBERTY LAKE
SPOKANE COUNTY, WASHINGTON**

**A RESOLUTION PROVIDING FOR THE DISPOSAL OF A CERTAIN ASSET ITEM
DEEMED TO BE SURPLUS AND NO LONGER USED BY THE CITY OF LIBERTY
LAKE, WASHINGTON**

WHEREAS, a certain piece of equipment that belongs to the City of Liberty Lake (“City”) is no longer needed by the City; and

WHEREAS, the equipment is a 2003 Ford Cut-Away Van (“Van”) that was received from the Spokane Transit Authority (STA) in 2012; and

WHEREAS, the City uses the Van for transportation for Seniors, City events, and other special programs; and

WHEREAS, the Van is no longer operational and the cost to repair the Van is excessive to the Van’s current value; and

WHEREAS, the City was awarded a new Van from STA in 2016; and

WHEREAS, the City believes that it is in the best public interest to authorize the Mayor or designee to dispose of the equipment to the best advantage of the City.

NOW, THEREFORE, be it resolved by the City Council of the City of Liberty Lake, Washington, as follows:

The 2003 Ford Cut-Away Van belonging to the City of Liberty Lake as shown in Exhibit A is declared to be surplus to the foreseeable needs of the City and it is deemed to be for the common benefit of the residents of the City to dispose of said asset. The Mayor is authorized to dispose of the items listed in this Resolution in a manner that will be to the best advantage of the City of Liberty Lake.


