**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LIBERTY LAKE,  
SPOKANE COUNTY, WASHINGTON, SUPPORTING THE LIBERTY LAKE  
UPLANDS TRAIL**

WHEREAS, the City of Liberty Lake is a growing community with many needs, including the need for areas with public access whereby residents can enjoy recreational and outdoor activities; and

WHEREAS, the citizens of the City of Liberty Lake value its natural resources and outdoor recreation opportunities and will greatly benefit from recreational and natural experiences; and

WHEREAS, the residents of Liberty Lake have benefitted from the acquisition of important natural lands near the Liberty Lake community and throughout Spokane County; and


WHEREAS, open space land which can be acquired with tax money includes lands, the preservation of which, would, among other matters: (1) conserve and enhance natural or scenic resources; or (2) protect streams or water supplies; or (3) promote conservation of soils, wetlands, or beaches; or (4) enhance the value to the public of abutting or neighboring parks, forests, wildlife preserves, nature reservations or sanctuaries or other open space; or (5) enhance recreation opportunities; or (6) preserve historic sites; or (7) preserve visual quality along highways, roads, and street corridors or scenic vistas; and

WHEREAS, on June 7, 2016, the Liberty Lake City Council approved a budget amendment to purchase property referred to as the Liberty Lake Uplands; and

WHEREAS, it is the desire of the Liberty Lake City Council to support the progression of the Liberty Lake Uplands Trail to preserve open space, views of Liberty Lake and provide connectivity to the Saltese Uplands Conservation Area;

NOW, THEREFORE BE IT RESOLVED THAT the City of Liberty Lake, Washington supports the improvement of the Liberty Lake Uplands to provide connectivity to the Saltese Uplands Conservation Area.


