

**RESOLUTION NO. 19-249
CITY OF LIBERTY LAKE
SPOKANE COUNTY, WASHINGTON**

**A RESOLUTION OF THE CITY OF LIBERTY LAKE, WASHINGTON, CHANGING
THE NAME OF THAT SECTION OF “NORTH HENRY ROAD”, LOCATED NORTH
OF EAST SPRAGUE AVENUE AND EXTENDING NORTHEAST TO EAST COUNTRY
VISTA DRIVE, TO “NORTH KRAMER ROAD”**

WHEREAS, on August 15, 2017, the City Council of the City of Liberty Lake adopted the Spokane County Regional Road Naming Addressing Standards through City of Liberty Lake Ordinance No. 244, which added a new Chapter 2 to Title 9 of the City of Liberty Lake Municipal Code entitled “Public Safety Street Naming and Physical Addressing Standards”; and,

WHEREAS, the purpose of Ordinance 244 was to provide a uniform method for naming streets and assigning addresses for property within the City of Liberty Lake, consistent with other jurisdictions in Spokane County, in order to facilitate expedient emergency response by medical, law enforcement, fire, rescue, and other emergency services; and,

WHEREAS, Ordinance 244 requires that a proposed street which is a continuation of, or in alignment with, an existing street or road shall continue the street/road name; and,

WHEREAS, Ordinance 244 states that duplicate street names will not be allowed, and further, that streets and/or roads with the same root name but a different suffix (that are not in alignment with the existing street/road) will be considered as duplicate road names, and thus disallowed; and,

WHEREAS, a new private road has been proposed to provide access to Central Valley School District’s proposed Ridgeline High School, and other adjacent properties, in alignment with existing South Henry Road; and,


WHEREAS, in accordance with the requirements of Ordinance 244, the new private road should be named “North Henry Lane” or “North Henry Court”, which would result in a duplicate street name, unless the existing “North Henry Road” was renamed; and,

WHEREAS, north of East Sprague Avenue, the existing “North Henry Road” does not follow the alignment of South Henry Road, but instead veers in a northeasterly direction along a 45 degree trajectory, thus making it an appropriate candidate for renaming.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LIBERTY LAKE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

That the section of “North Henry Road” located north of East Sprague Avenue and extending northeastward to East Country Vista Drive be renamed “North Kramer Road”, consistent with the road naming requirements of City of Liberty Lake Ordinance No. 244.


