

**ORDINANCE NO. 53  
CITY OF LIBERTY LAKE  
SPOKANE COUNTY, WASHINGTON**

**AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON, ADOPTING  
BY REFERENCE THE SPOKANE COUNTY BUILDING PERMIT FEE SCHEDULE AS  
THE INTERIM BUILDING PERMIT FEE SCHEDULE OF THE CITY.**

WHEREAS, the City of Liberty Lake will incorporate on August 31, 2001; and

WHEREAS, the City of Liberty Lake is required to adopt building permit fees within the corporate limits of the City;

WHEREAS, Spokane County adopted a Building Permit Fee Schedule effective November 2000, which is in effect within the City of Liberty Lake;

WHEREAS, Spokane County reviews and updates Building Permit Fees periodically, which includes fees within the City of Liberty Lake; and

WHEREAS, after the date of incorporation, the City of Liberty Lake intends to develop its own Building Permit Fee Schedule.

NOW, THEREFORE, the City Council of the City of Liberty Lake, Washington, do ordain as follows:

**Section 1.** Building Permit Fees. Pursuant to RCW 35.21.180, 35A.11.020 and 35A.21.160, the City adopts by reference the Spokane County Building Permit Fee Schedule effective November 2000, which is attached hereto as Exhibit "A" and incorporated herein by this reference as presently constituted or hereinafter amended as the interim Building Permit Fee Schedule of the City of Liberty Lake. Unless the context requires otherwise, references to Spokane County shall be construed to mean the City of Liberty Lake.

**Section 2.** Adoption of Other Laws. To the extent that any provision of the Spokane County Code, or any other law, rule or regulation referenced in the attached Building Permit Fee Schedule is necessary or convenient to establish the validity, enforceability or interpretation of the Building Permit Fee Schedule, then such provision of the Spokane County Code, or other law, rule or regulation is hereby adopted by reference.

**Section 3.** Reference to Hearing Bodies. When the attached Building Permit Fee Schedule refers to planning commissions, board of appeals, hearing examiner, or any other similar body, the City Council shall serve in all such roles, but retains the right to establish any one or more of such bodies, at any time and without regard to whether any quasi-judicial or other matter is then pending.


**Section 4.** Uniform Code - Copies on File. The City Clerk is to maintain one copy on file of the Building Permit Fee Schedule adopted by this ordinance.

**Section 5.** Liability. The express intent of the City of Liberty Lake is that the responsibility for compliance with the provisions of this ordinance shall rest with the permit applicant and their agents. This ordinance and its provisions are adopted with the express intent to protect the health, safety, and welfare of the general public and are not intended to protect any particular class of individuals or organizations.


**Section 6.** Severability. If any section, sentence, clause or phrase of this ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 7.** Effective Date. This Ordinance shall be in full force and effect five (5) days after publication of the Ordinance Summary, and on the date of incorporation.

**NOTICE OF ORDINANCE PASSED  
BY LIBERTY LAKE CITY COUNCIL**

The following is the title and summary of Ordinance No. 53 passed by the City of Liberty Lake City Council on the 21<sup>st</sup> day of August, 2001.

**AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON, ADOPTING  
BY REFERENCE THE SPOKANE COUNTY BUILDING PERMIT FEE SCHEDULE AS  
THE INTERIM BUILDING PERMIT FEE SCHEDULE OF THE CITY.**

The introductory paragraphs state the City adopts the Spokane County Building Permit Fee Schedule.

**Section 1** adopts by reference Spokane Building Permit Fee Schedule.

**Section 2** adopts other laws, rules and regulations referenced in the Building Permit Fee Schedule.

**Section 3** states the City Council shall serve in the role of planning commission and hearing examiner unless otherwise provided by ordinance.


**Section 4** states the Building Permit Fee Schedule is on file with the City Clerk.

**Section 5** states the Ordinance is to protect the public health, safety and welfare.

**Section 6** establishes a severability clause in the event some portion of the Ordinance is held invalid.

**Section 7** states this Ordinance shall be in full force and effect five (5) days after publication of the Ordinance Summary, and on the date of incorporation.
