ORDINANCE NO. 6A
CITY OF LIBERTY LAKE
SPOKANE COUNTY, WASHINGTON

AN ORDINANCE AMENDING ORDINANCE NO. 6 PASSED BY THE CITY COUNCIL ON JUNE 5, 2001 AND ENTITLED "AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON, ADOPTING THE INTERIM BUDGET THROUGH AUGUST 31, 2001", AND DECLARING AN EMERGENCY.

WHEREAS, subsequent to the adoption of the Interim Budget Ordinance No. 6, passed by the City Council on June 5, 2001, it is necessary to make changes in the appropriations of the General Fund, which changes could not have been anticipated or known at the time of the making such budget ordinance; and

WHEREAS, pursuant to RCW 35A.34.140, the City will incur expenses incident to establishing the new form of government including selection of new employees and consultants; and

WHEREAS, to be effective this Ordinance must be approved by the City Council by a majority plus one;

NOW, THEREFORE, the City Council of the City of Liberty Lake, Washington, do ordain as follows:


Section 1. That in the budget of the General Fund, and the budget annexed thereto with reference to the General Fund, the following changes be made:

From: 513.10.10.02	City Administrator	\$10,700.00
558.10.10.00	Planning Director	4,725.00
513.10.20.00	Benefits	3,200.00
558.10.20.00	Benefits	1,417.00
To: 513.10.41.01	Professional Services	\$20,042.00

Section 2. The City Council declares that an urgency and emergency exists for making the changes set forth herein, such urgency and emergency arising from the need to contract with various individuals and consultants to assist in service provision contracts, the need for which could not be reasonably have been anticipated at the time of adoption of the interim budget, and because of such need, an urgency and emergency exists to protect the public health, safety and welfare this Ordinance shall take effect and be in force immediately upon its passage.


Section 3. Severability. Should any section, paragraph, sentence, clause of phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal laws or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.


