ORDINANCE NO. 05A**

**AN ORDINANCE AMENDING ORDINANCE NO. 05 PASSED BY THE
CITY COUNCIL OF THE CITY OF LIBERTY LAKE, WASHINGTON,
APPOINTING AN AUDITING OFFICER.**

WHEREAS, RCW 42.24.080 requires the City of Liberty Lake to appoint an Auditing Officer;

WHEREAS, the Auditing Officer is required to audit before payment all claims presented to the City on behalf of persons furnishing materials, rendering services or performing labor, or for any other contractual purpose with such claims prepared for audit and payment on a form approved by the State Auditor;

WHEREAS, the Auditing Officer must certify that the materials have been furnished, the services rendered or the labor performed with such claim being an obligation of the City of Liberty Lake; and

WHEREAS, no claim shall be paid without such authentication and certification.

NOW, THEREFORE, the City Council of Liberty Lake, Washington do ordain as follows:

Section 1. Appointment. The City Council hereby appoints the Administrative Services Manager or, in the absence of the Administrative Services Manager, the City Clerk as the Auditing Officer. The Auditing Officer is required to perform all duties set forth in RCW 42.24.080, including the authentication and certification of claims against the City of Liberty Lake.

Section 2. Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

Section 3. Effective Date. This Ordinance shall be in full force and effect five (5) days after publication of this Ordinance or a summary thereof in the official newspaper of the City as provided by law.
