

**ORDINANCE NO. 181-B  
CITY OF LIBERTY LAKE  
SPOKANE COUNTY, WASHINGTON**

**AN ORDINANCE AMENDING ORDINANCE NO. 181 PASSED BY THE CITY COUNCIL ON DECEMBER 1, 2009, ENTITLED "AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON, ADOPTING A BUDGET FOR THE PERIOD JANUARY 1, 2010, THROUGH DECEMBER 31, 2010, APPROPRIATING FUNDS AND ESTABLISHING SALARY SCHEDULES FOR ESTABLISHED POSITIONS".**

WHEREAS, state law provides for the adoption of a budget by the City Council of the City of Liberty Lake for the purpose of making appropriations of the total estimated revenues for each separate fund and the aggregate totals for all such funds combined;

WHEREAS, the following changes could not reasonably have been anticipated or known at the time Ordinance 181 was passed by the City Council;

WHEREAS, on August 17, 2010, the City Council adopted Ordinance No. 181-A, amending Ordinance No. 181;

WHEREAS, certain revisions to the 2010 budget are now necessary;

NOW, THEREFORE, the City Council of the City of Liberty Lake, Washington, do ordain as follows:

**Section 1.** The Municipal Library Fund 101 fund balance as of December 31, 2010 is transferred to the General Fund 001 and establishes the Municipal Library in the General Fund. Upon completion of the transfer, Fund 101 is closed.

**Section 2.** There is hereby created a Street Light Utility Fund in the General Fund 002. This fund shall be used for the revenue collection and disbursement for expenditures related to street light illumination, maintenance, and replacement.

**Section 3.** Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

**Section 4.** Effective Date. This Ordinance shall be in full force and effective (5) days after publication of this Ordinance or a summary thereof in the official newspaper of the City as provided by law.
