ORDINANCE NO. 135**

**AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON
REGULATION THE USE OF MOTORIZED SCOOTERS TO INCLUDE
EQUIPMENT AND OTHER OPERATIONAL REQUIREMENTS AND
PROVIDING FOR THE EFFECTIVE DATE THEREOF.**

WHEREAS, the City Council of the City of Liberty Lake desires to regulate the use of motorized scooters to enhance the health, safety and welfare of its citizens; and

WHEREAS, the City Council of the City of Liberty Lake finds that driving rules as to the proper operation of motorized scooters would increase the health, safety and welfare of its citizens; and

WHEREAS, the City Council of the City of Liberty Lake finds that providing minimum requirements as to motorized scooters, lighting and other equipment would increase the health, safety and welfare of its citizens;

NOW, THEREFORE, the City of Liberty Lake, in regular meeting assembled, do ordain as follows:

Section 1. The following definition shall be used in this ordinance.

A. Motorized foot scooter” means a device with no more than two ten-inch or smaller diameter wheels that has handlebars, is designed to be stood or sat upon by the operator, and is powered by an internal combustion engine or electric motor that is capable of propelling the device with or without human propulsion.

Section 2. Purpose. For purposes of this section, a “pocket bike”, and “mini chopper” are considered motorized foot scooters. A motor driven cycle, a moped, an electric assisted bicycle, or a motorcycle is not a motorized foot scooter.

A. Motorized foot scooters shall not be operated upon a public roadway by any person under the age of sixteen years.

B. Motorized foot scooters shall not be operated on public roadways with a speed limit of greater than 25 miles per hour.

C. Operators of motorized foot scooters shall adhere to all rules of the road applicable to motorized vehicles.

D. Motorized foot scooters shall not be operated on City owned property, City Parks, walkways, paths, trails, sidewalks, or any other place where other motorized vehicles are expressly prohibited.

E. Motorized foot scooters shall not be operated on publicly owned parking lots, and privately owned parking lots without the permission of the owner.

F. Motorized foot scooters shall not be operated at any time during one half hour after sunset to one half hour before sunrise unless equipped with a lamp on the front which shall emit a white light visible from a distance of a least five hundred feet to the front and with a red reflector on the rear of a type approved by the state patrol which shall be visible from all distances up to six hundred feet to the rear when directly in front of lawful low beams of head lamps on a motor vehicle. A lamp emitting a red light visible from a distance of five hundred feet to the rear may be used in addition to the red reflector. A light emitting diode flashing taillight visible from a distance of five hundred feet to the rear may also be used in addition to the red reflector.

G. No person shall transport or tow another person on, in or with a motorized foot scooter within the City of Liberty Lake.

H. Motorized foot scooters shall not be operated in a negligent manner within the City of Liberty Lake. For the purposes of this section, to operate in a negligent manner means to operate a motorized scooter in such a manner as to endanger any person or property, or to obstruct, hinder or impede the lawful course of travel of any motor vehicle or the lawful use by any pedestrian of public streets, sidewalks, paths, trails, walkways, or parks.

I. Motorized foot scooters shall be equipped so that the drive motor is engaged through a switch lever or other mechanism that when released will cause the drive motor to disengage or cease to function.

J. It is unlawful for any parent, guardian or other person having control or custody of a minor child to allow said minor to operate a motorized foot scooter in violation of this chapter.

K. Any person operating a motorized foot scooter while in the City of Liberty Lake shall wear an approved helmet designed for safety and shall have either the neck or the chin strap of the helmet fastened securely while the motorized foot scooter is in motion.

L. Helmet means a protective covering for the head consisting of a hard outer shell, padding adjacent to the inside hard shell, and a neck or chin strap type retention system, with a label required by the Federal Consumer Product Safety Commission adopted by the Code of Federal Regulations 16 CFR 1203.


M. Operation of a motorized foot scooter is subject to provisions of the Liberty Lake noise ordinance. Operation of a gas motorized foot scooter without a muffling device, or operation with a modified muffling device is unlawful.

Section 3. Penalty of Noncompliance. Upon a determination of a violation of this chapter has occurred, law enforcement officers may, at their discretion, issue a civil infraction not to exceed \$250.00 to any included person, including their parent or guardian, in violating any provisions of this chapter.

Section 4. Severability. If any section, sentence, clause or phrase of this ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect five (5) days after publication of this Ordinance or a summary thereof in the official newspaper of the City as provided by law.

**NOTICE OF ORDINANCE PASSED
BY LIBERTY LAKE CITY COUNCIL**

The following is the title and summary of Ordinance No. 135 passed by the City of Liberty Lake City Council on the 4th day of January, 2005.

**AN ORDINANCE OF THE CITY OF LIBERTY LAKE, WASHINGTON
REGULATING THE USE OF MOTORIZED SCOOTERS TO INCLUDE
EQUIPMENT AND OTHER OPERATIONAL REQUIREMENTS AND
PROVIDING FOR THE EFFECTIVE DATE THEREOF.**

The introductory paragraphs state that the City desires to regulate the use of motorized scooters to enhance the health, safety and welfare of its citizens.

Section 1 defines the terms "Motorized foot scooter", "Motorized Skateboard", "Motorized Personal Transportation Device ("MPTD")", and "Street".


Section 2 establishes use, operational and equipment requirements and restrictions adopted by the City for motorized foot scooters.

Section 3 establishes penalties for noncompliance upon a determination that a violation of the ordinance has occurred.

Section 4 establishes a severability clause in the event some portion of the Ordinance is held invalid.

Section 5 states that this Ordinance shall be in full force and effect five (5) days after publication of the Ordinance Summary.
