2022-2027 TRANSPORTATION IMPROVEMENT PLAN PROJECT DESCRIPTIONS

Project Types

New Construction: Includes construction of new roadways, trails, multimodal paths, etc. Includes

project that increase roadway capacity (e.g. adding additional lanes, widening

bridge structures, etc.)

Preservation: Projects that significantly extend the useful life of transportation infrastructure,

including full rebuild, overlays, grind & overlays, etc.

Enhancement: Capital improvements that improve & enhance existing transportation

infrastructure (i.e. new sidewalks, pedestrian crossings, traffic calming, landscaping improvements, operational traffic improvements including signals,

roundabouts, and turn pockets).

Maintenance: Spot repairs, including crack seal, pothole repairs, striping, new and/or

replacement signage, etc.

Plan/Report: Technical studies, plans or reports that provide a basis for identifying and

prioritize capital projects, and/or strategies for implementing capital investments

(i.e. corridor studies, sidewalk master plan, pavement condition study)

Project Descriptions

New Construction:

Line 1: I-90/ Improve Interchanges & Local Roads: Combined funding for Harvard & Kramer Parkways, as state funding is intertwined, and depends on credits for ROW, design work being completed by the City's consultant, etc. Kramer Parkway Bridge design was completed in early 2021 with construction beginning in the summer of 2021 and continuing in 2022. Note that CFP costs for this project reflect combined City-State costs.

Line 1A: Harvard Rd Bridge Widening/ I-90 Westbound On-Ramp: Harvard Road Bridge widening is currently under construction, with construction anticipated to be completed by fall of 2021. Cost savings realized on the construction of this portion of the project will roll into Kramer Parkway Overpass & Roadway Extension.

Line 1B: Kramer Parkway Overpass & Roadway Extension: Bid openings for this project are anticipated in late May, with construction beginning this summer and extending into 2022. The project includes a roundabout connection at Mission Avenue, and a signalized intersection connection at Country Vista.

Preservation Projects:

- Line 2: Country Vista Reconstruction / Operational Improvements: Improvement costs to include design construction, inspection and contingency, for the reconstruction of Country Vista Drive, from western City limits to Liberty Lake Road. Traffic calming enhancements and operational corridor improvements to include landscape medians and pedestrian crossings, as may be identified in Network Analysis and Corridor Study. Design funding has been moved up to 2022, to allow time for application to potential grant sources, with construction planned for two phases, in 2024 and 2025.
- **Line 3: Kramer Parkway Reconstruction:** Based upon geotechnical evaluation of the roadway, the planned overlay project has been updated to a reconstruction project, with cost updated based upon actual design. Originally planned for construction in 2024, construction is now proposed for 2022 based on current roadway conditions. Staff is preparing an application for possible TIB grant funding at 70%.
- **Line 4: Mission Avenue Overlay:** This grind and overlay project from Country Vista Drive to Molter Ave, funded for 2022 as part of the 2021-2026 TIP, is now proposed to be delayed to 2023 in the current CFP, given relative roadway conditions, and in order to accommodate the advancing of the Kramer Parkway Reconstruction.
- **Line 5: Sprague Avenue Overlay:** Potential grind and overlay project from Liberty Lake Road to Gage Lane is proposed for 2026 for possible TIB grant funding at 70%.
- **Line 6:** Appleway Overlay: Overlay project from Fairway Lane to E City Limits, is a new project, based upon current roadway conditions. Staff will apply for potential TIB funding in 2022, for funding in 2023.

Enhancements:

- **Line 7:** Appleway Improvements: Improvement costs from Fairway Lane to E City limit include design, construction, inspection and contingency for addition of center turn lane, sidewalks, swales, and street trees along frontages not subject to developer improvements, and the addition of medians consistent with Appleway Avenue's aesthetic corridor designation. While construction is proposed for 2027, design is proposed for 2025 to accommodate potential grant application cycles.
- **Line 8:** Harvard Rd & Wellington Intersection Improvements (roundabout): Improvements to be constructed by Greenstone as part of River Crossing East required infrastructure improvements, with design anticipated in 2020, and construction anticipated in 2021.
- **Line 9:** Country Vista & Legacy Ridge Intersection Improvements: Intersection improvements to include design in 2020, and construction, inspection and contingency in 2021, for traffic signal and pedestrian crossing, as identified by the Network Analysis and Corridor Study.

- **Line 10:** Indiana & Harvard Rd Intersection Improvements (signal): Improvements to be constructed by Greenstone as part of River Crossing East required infrastructure improvements, with design anticipated in 2021, and construction anticipated in 2022.
- Line 11: Ridgeline HS Main Entrance Intersection Improvements (signal): Addition of a signal at entrance to Ridgeline High School and Country Vista Drive, with design in completed in 2020, and construction in 2021. 70% of the cost is covered by a TIB grant.
- Line 12: Appleway/Country Vista Blvd Intersection Improvements (turn lane): Intersection improvements to include design, construction, inspection and contingency, for the addition of a right turn lane. Design planned for 2022, with construction in 2023.
- **Line 13:** Kramer Parkway Frontage Improvements: Required subdivision improvements for Legacy Ridge West, including curb, swales, sidewalks, street trees, and turn pockets, to be constructed by the Holt Group. Anticipated to be constructed in 2020.
- Line 14: Mission Avenue Improvements, Harvest Parkway to Corrigan Road: Development-driven frontage improvements to include turn pockets, curb swales, sidewalks and street trees, required to be completed by the developer as development occurs along the frontage of Mission Avenue. Timing for the project has been adjusted, based upon the status of Greenstone's River Crossing 2020 Plat, and the conditions of plat approval.
- Line 15: Mission Ave Frontage Improvements, City Limits east to Glenbrook (south side): City project to include acquisition of right-of-way, and design, construction, inspection and contingency for road widening, curbs, swales, street trees and sidewalks along the south side of Mission Avenue, from City limits east to Glenbrook, with design planned in 2025 and construction planned for 2026.
- **Line 16: Sidewalk Improvements, Madson, Mission to Appleway:** Proposed construction of missing sidewalks on either side of Madson, south of Appleway in 2026. Design will occur in 2025 to allow for potential grant funding.
- Line 17: Street, Pathway, Pedestrian Safety Improvements: Funding for pedestrian crossing improvements and flashing beacons, as updated in the 2021-2026 Capital Facilities Plan. Funding proposed in 2021 provides for crossings at Winrock @ Autumn Crossing, Country Vista @ Eagle Bend, and Country Vista @ Eagle Lane. Proposed projects for 2022 include Mission @ Bitterroot, Boone @ Malvern, and Boone @ Stevenson. The project planned for 2023 (Country Vista @ Sharp) could potentially be moved to 2022 based upon savings realized in 2021 project bids.

Maintenance:

Line 18: Street Maintenance: Annual maintenance allocation to address major maintenance projects (as encountered in recent years on Mission Avenue and Kramer Pkwy), along with crack sealing, pothole repair, striping, sign replacement, and other ongoing maintenance & repair activities, as may be identified by the Street Crew. The annual amount has been increased to \$100,000 to reflect the cost of recent street maintenance and repair projects.

Line 19: Sidewalk & Pathway Maintenance: Annual maintenance allocation to address major sidewalk and trail maintenance projects, such as repaving of trails, or repair/replacement of ADA accessible pedestrian ramps, along with minor maintenance and repair activities, to include crack-sealing, sidewalk grinding or lifting, etc.

Plans/Studies:

- Line 20: Pavement Condition Study/Preservation Master Plan: An analysis of pavement condition throughout the City to serve as a basis for establishing a systematic pavement maintenance program to extend the useful life of City streets based on roadway conditions and projected useful. Proposed for implementation in year 2022, costs include software, scan of street pavement condition, sidewalk condition, ongoing updates to pavement assessments and periodic updates to plan.
- **Line 21**: **Sidewalk Master Plan:** Funding for potential project in moved to 2020 to allow inventory to be completed and incorporated in pavement condition software as a foundation to the masterplan to identify and prioritize pedestrian projects.
- **Line 22: Trail Lighting Master Plan:** Included in Capital Facilities Plan for funding 2022, this project is proposed to be deferred to 2023, given 2022 project priorities to include coordination of ongoing construction on Kramer Parkway Overpass, the Kramer Parkway Reconstruction, along with other Capital Projects in the pipeline.

Planned TIF/LIFT Eligible Infrastructure Projects Included in the CFP, but not TIP:

The following TIF/LIFT-eligible projects that are not currently located on public property will be constructed by others for dedication to a public entity.

- **Line A:** Transit Parking (on STA property)
- Line B: Cataldo Extension Phase 1 (associated with Western States CAT Project)
- **Line C:** Cataldo Extension Phase 2 (extension from Western States CAT to tie into Kramer Parkway Extension)
- **Line D:** Indiana Avenue (Trutina Development east of Harvard Rd.)
- **Line E:** Indiana Ave Construction (Bitterroot East to Harvard Rd.)
